



INDIAN SCHOOL OF PUBLIC POLICY

Indian School of Public Policy (ISPP) was launched in October 2018 with the dual objectives of democratising public policy education and engagement in India and facilitating the development of policy capacities across samaj, sarkar and bazaar.

In line with our vision, ISPP offers five key academic programmes:


1.Post Graduate Programme in Policy, Design & Management: ISPP's flagship 1-year course, currently in its fifth year with a batch of 48 scholars.

2.LokNeeti: Targeted at working professionals, this 4-month hybrid programme is an intensive capsule course on the essentials of public policy.

3.Executive Education Programmes: These are customised to meet specific corporate and government officials' training requirements.

4.Public Policy for Young Professionals: A 21-hour Massive Open Online Course on public policy designed in partnership with Larsen & Toubro for young professionals.

5.Knowledge partnership with Capacity Building Commission (Gol): A research and training collaboration with the Capacity Building Commission for Mission Karmayogi, Gol's capacity-building initiative for civil servants. Along with developing capacity-building modules, ISPP's Case Study Centre is working closely with the Commission to develop cutting-edge public policy case studies for training civil servants.



ABOUT POST GRADUATE PROGRAMME IN

PUBLIC POLICY, DESIGN AND MANAGEMENT

(ONE YEAR FLAGSHIP PROGRAMME)

ISPP's one-year post-graduate programme in Public Policy, Design and Management runs from August to July of every year. The programme is divided into 7 terms of 7 weeks each with the final term reserved for the capstone exercise that puts all their learning's into practice. The programme is operationalised through three components: Courses, which each run for 24 hours, workshops which run for 10-12 hours, and domains which run for 24 hours.

The training is divided into two parts. One is the analysis of public policy. This involves learning the techniques used to evaluate policies. Courses in economics, statistics, etc., are aimed to provide these tools to the scholars. The other part of the training in public policy involves the understanding of what is public policy, what are the principles and political philosophy determining what and how policy achieves its objectives. Courses in politics, political economy, game theory, etc., are aimed at this second aspect of the training.

The programme also keeps an important consideration into mind. What works in public policy is determined largely by the context within which these policies are implemented, as well as the particular nature of the problem the policy is addressing. E.g., policy governing healthcare is very different from that governing school education. This third aspect of public policy was kept in mind while developing the programme. We have identified 7 domains--- education, environment, food systems & rural development health, infrastructure, technology, and urbanization, to train our scholars in mastering this third aspect.

In addition to this as a part of this programme, University Of Chicago, offers ISPP scholars a Credential in International Development and Public Policy upon successful completion, through a series of workshops and lectures, held at ISPP and conducted by faculty, practitioners and other experts associated with the University of Chicago.

Labs & Workshops at ISPP

1. Writing and Communication Lab (WCL): Engaging public policy stakeholders requires a sound understanding of the policy landscape, skills to conduct research, write scientifically, and the ability to repurpose scientific writing into communication formats that suit stakeholders. The Writing and Communication Lab (WCL) at ISPP offers apprentice-style training to develop scholars' verbal, non-verbal and writing skills to effectively communicate in development, corporate, and academic settings. The Lab also works closely with the Careers team to support students' career development needs.





2. Policy Praxis Lab (PPL): Public policy governs every action one takes as well as the outcomes of these actions. The Policy Praxis Lab will train one to understand why and how to make public policy work for the public. The lab explores a range of policy-related questions: How should markets be organised? What is health policy? How does public policy handle the diverse interests of people? How do we find out these diverse interests? How do we make people agree on a common set of choices, allowing them to choose differently from the same set?

Through a series of policy exercises characterised by curiosity and empathy, through thought experiments as well as real-life experiences of successful and unsuccessful policy interventions, scholars will be trained to master the science and art of ethical policy objectives.

3. Antarang Leadership Lab (ALL): The Antarang Leadership Lab (ALL) is an experiential lab. It is meant to create a comfortable space where scholars can have conversations amongst friends on issues that are relevant to their personal development as leaders. ALL give our scholars hands-on, practical experience to build their leadership skills to help them both at ISPP and when they start working. It aims to make our scholars more aware of themselves and their surroundings. This year we have 30 mentors on board as part of ALL.





4. Public Policy & Corporate workshop: The Public Policy and Corporate workshop introduces scholars to the intricacies of public policy and corporate strategies. By hosting a line-up of esteemed industry experts and professionals, the scholars will understand the complexities of stakeholder management. They will also study the role of advocacy in building trust and developing effective coalitions. The workshop will build upon their existing training with the aim of transforming scholars into policy professionals who can effectively engage with governments.

Collaboration with Harris School of Public Policy, UChicago


Admissions

1. Eligibility:

ISPP's year-long programme in Public Policy, Design & Management (PDM) is open to any individual who has completed their undergraduate studies, regardless of discipline, from an Indian or International University. Applicants who are currently enrolled in the final year of their undergraduate studies or have completed their undergraduate in the current academic year are not eligible for the PDM programme.




