## Shaping India's Future: The Policy Path of Nipun Rathi

Mr. Nipun Rathi (PDM Class of 2021) is a keen, creative, learning-oriented professional with extensive experience working across governments, corporates, and consultancies. He is a qualified Chartered Accountant from the Institute of Chartered Accountants of India and holds a postgraduate degree in Public Policy, Design, and Management from the Indian School of Public Policy (ISPP), India. He is currently heading the Public Policy & Government Affairs department at boAt Lifestyle. In his earlier career as a public policy professional, he worked in various organizations like OPPO Mobiles India Pvt. Ltd., the Ministry of Electronics & Information Technology (GoI), the Ministry of Commerce & Industry (GoI), and the Planning Department, Government of Rajasthan.

Initially, working in roles like audit & assurance services, institutional equity research, wholesale capital markets, and wealth advisories, Nipun transitioned into roles like policy research & analysis, trade & investment promotion, policy advocacy, stakeholder management, and business strategy formulation roles. What brought a major chance in his approach towards looking to various problems & evaluating their complex solutions was his initial role as Policy Analyst while working with Planning Department, Government of Rajasthan. During that work stint, he was able to appreciate the fundamental, yet critical role played by Government & it's governance machinery in bringing a holistic and sustainable growth in the country. He was now more motivated to work actively with Government & quasi government bodies going ahead.

# Nipun Rathi Appointed as Head of Public Policy & Government Affairs at boAt Lifestyle.

Later, he worked with various wings of the Government of India like the Ministry of Commerce & Industry, Niti Aayog, and Ministry of Electronics & IT (MeitY) on various trade & non-trade policies and incentive schemes of the Government of India. Working as programme manager on Production Linked Incentive (PLI) Scheme, evaluating Foreign Direct Investments (FDI) clearances, working on WTO & custom laws, supporting corporates to develop business strategies according to mandates of Indian Governments & its policies, providing supply chain & cost optimisation solutions, conducting policy advocacies for new & emerging technological domains, managing empowered committees meetings involving multiple departmental secretaries, handling Government auditors programme Management Units, drafting parliamentary questions, getting policy & regulatory approvals from other allied ministries & departments were his few major work assignments in these Government roles.

His educational training in Public Policy from ISPP proved very handy for him to work on such complex and challenging roles as aforementioned. ISPP courses like economics and law, trade and global strategy, critical thinking, politics in public policy, game theory, statistics, behavioural sciences, design thinking, policy communications, market for development, etc., helped him shape as a holistic policy professional.

With his experiences working across sectors, including ESDM, Telecom, Financial Services, Consumer and retail, Digital Economy, emerging technologies, etc., and his diversified skillsets, he foresees continuing to develop and implement creative yet solution-oriented policies for India in the future. #### From Economics to Empowerment: Praneta Kansal's Journey in Public Policy

Praneta Kansal (PDM Class of 2024)'s journey began with a deep-seated curiosity about the economic forces that shape society. This interest led her to pursue a Master's in Economics from Panjab University, where she built a solid foundation in both theoretical and quantitative methods. During this time, she developed key skills in microeconomics, econometrics, and quantitative analysis—skills that would later become invaluable in her public policy career.

However, her curiosity wasn't just academic; she was eager to apply her learning to real-world challenges. This drive became the cornerstone of her career when she embarked on her postgraduate journey at the Indian School of Public Policy (ISPP). The programme was a transformative experience that not only shaped her perspective on policy design and implementation but also deepened her understanding of various policy domains, including health, urbanization, and environmental sustainability.

At ISPP, Praneta Kansal was able to combine her passion for economics with practical policy challenges. One such project involved leading an independent study on illegal construction in Sangrur, where she applied both qualitative and quantitative research methods to analyze district-level data and inform macro-level policy recommendations. This experience allowed her to see firsthand how the theory of change, an intellectual tool, can be used to solve pressing societal issues.

# Empowering Senior Citizens: Praneta Kansal's Role at Inspiring Seniors Foundation

Her engagement in public policy was further enriched by her role as Associate Editor for the ISPP Policy Review. Through editing articles and policy briefs, she honed her critical thinking and communication skills—both essential in articulating complex policy issues clearly and persuasively. This experience reinforced the importance of effective communication in driving meaningful policy change.

The most fulfilling chapter of her career, however, began when she joined the Inspiring Seniors Foundation (ISF). As programme Manager, she manages various aspects of social media and website development, but her role goes far beyond that. She is at the forefront of implementing programmes that empower senior citizens—one of the most rewarding aspects of her work. Praneta has had the opportunity to lead initiatives such as the Health Hub, which includes programmes like Chat with Doctor and Daily Dose of Health, both of which were developed with the guidance and support of ISF.

Much of her groundwork for these initiatives was laid during her internship at ISF, where she helped develop a mentoring guide that improved programme comprehension, facilitated stakeholder analysis for senior citizen-related services, and played a key role in designing a website that quickly attracted volunteers. These projects, with their tangible impact, solidified her belief in the power of policy-driven social change.

Looking back, Praneta Kansal can see how each experience has shaped the professional she is today. From developing a strong foundation in economics to applying those skills to real-world policy issues, and now working to empower senior citizens through innovative programmes, her career has been a journey of continuous learning and impactful work.





#### Srijeet Mukherjee: Championing Educational Reform through Public Policy

Srijeet Mukherjee (LokNeeti Class of February 2024) is a seasoned education and language professional with over 10 years of experience across for-profit, start-up, public university, and non-profit sectors. With a background in Linguistics and English Literature, Srijeet began his career at Oxford University Press, gaining insights into private education before transitioning to roles where he could drive broader social impact. As an Educational Specialist at Educational Initiatives Pvt Ltd, he developed assessments to evaluate language proficiency, recognizing the systemic issues of rote learning. This realization motivated him to edit and project-manage bilingual dictionaries at Oxford University Press, aiming to improve language accessibility in Indian regional languages, ensuring students weren't held back due to limited English skills.

In 2017, Srijeet was awarded the Fulbright Scholarship and served as a Foreign Language Teaching Assistant at the University of Montana, USA. This role allowed him to immerse students in Hindi, with some of his students securing prestigious scholarships to continue learning Hindi in India. He actively represented Indian culture and language on international platforms, demonstrating his passion for cross-cultural understanding.

Upon returning to India, Srijeet shifted his focus towards addressing the employability skills gap. At Harappa Learning Pvt. Ltd., he was involved in developing courses on communication, critical thinking, and problem-solving, as well as leading a team to create psychometric assessments. He also co-authored a Hindi Reader for elementary students at the University of California, Davis, reflecting his continued commitment to language education.

Motivated by the National Achievement Survey 2021 results, Srijeet pivoted to the non-profit sector, joining Vasant Valley School as a Project Manager for a curriculum development initiative in collaboration with the Delhi Board of School Education (DBSE). This role provided him insights into public education challenges, including teacher training, curriculum development, and systemic barriers to student literacy. Driven to address these foundational issues, Srijeet joined Central Square Foundation, where he led the assessment of foundational literacy and numeracy programmes in Haryana, Odisha, and Assam, supporting the NIPUN Bharat Mission.

Srijeet further advanced his understanding of policy and its impact on education by enrolling in the LokNeeti programme at the Indian School of Public Policy (ISPP). This course provided him with a deeper understanding of public policy mechanisms and prepared him for impactful assignments. Recognized for his leadership and dedication, Srijeet earned the LokNeeti Mashaal achievement certificate for his contributions to the programme.

Currently, as part of the Reach to Teach Foundation, Srijeet supports the Directorate of Educational Research and Training (DERT), Meghalaya, in developing syllabi, assessment blueprints, and activity books to improve foundational literacy and numeracy. He also leads State-Level Achievement Surveys (SLAS) aimed at improving public education outcomes. Additionally, as a part-time Designated Campus Colleague at the University of Arizona, Srijeet works on the "Learning Hindi Online through Current Social Issues" project, blending language education with cultural and social awareness. Srijeet's journey reflects his commitment to improving public education and his role in influencing public policy discourse.
